PRIVACY POLICY

SALT & SPICE SWIM™ takes your privacy seriously into account, thus we are committed to protecting and respecting your privacy. Please find hereunder some useful information on our Privacy Policy that describes how your personal information is collected, used, and shared when you visit or make a purchase from www.saltspiceswim.com. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

1. PERSONAL DATA WE COLLECT

o Information we collect about you

When you visit the Site, we may collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device-related Information."

We collect Device-related Information using the following technologies:

- "Cookies" are small pieces of data that are stored by your browser on your computer's hard drive, mobile phone or any other device used to access the internet. We use cookies to customize our website and improve your experience with the site. Cookies store anonymous information, such as whether you viewed the site from your mobile device, when or from which IP address. You are not required to accept any cookies to use the Site. However, deciding not to accept cookies will make the use of the Site more cumbersome and less accessible.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

2. WHY WE USE YOUR DATA

We use information held about you in the following ways:

· We use the Order Information that we collect generally to fulfil any orders placed through the Site (including processing your payment information, arranging for shipping, and providing you with invoices and/or order confirmations). This information is necessary for the performance of contract with you (e.g. to deliver the products you have purchased in our websites).

Additionally, we use this Order Information to:

- · Communicate with you
- · Screen our orders for potential risk or fraud; and
- · When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.
- \cdot We also use your order information to pass it to the courier company to deliver the parcel.
- · Subject to your explicit consent, we use newsletters subscription data exclusively for the purpose of sending you our newsletters or other promotional material.
- · We use the Device-related Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns). By accepting cookies you give us your consent to the use of device-related information.
- · We also use your Personal Data for remarketing including (but not limited to) Google AdWords, Facebook ads, Mailchimp and Contact Pigeon and Shoelace. We process your Personal Data for marketing purposes only when you give your consent thereto, which you may revoke at any time without any detriment.

3. SHARING YOUR PERSONAL INFORMATION/DATA

We share your Personal Information with third parties that help us provide you our services, as described above. Namely:

- · We use Google Analytics to help us understand how our customers use the Site--/to assist us in the improvement and optimization of our platform you can read more about how Google uses your Personal Information here: https://www.google.com/intl/en/policies/privacy/. You can also opt-out of Google Analytics here: https://tools.google.com/dlpage/gaoptout. To this end, we also pass your personal information to FB to create more targeted ads.
- \cdot We share your Personal Data with payment service providers for the purpose of completing your order;
- \cdot Also, we share your personal information to send you newsletters and keep you informed with our latest offerings.

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to any lawful request for information we receive, or to otherwise protect our rights.

4. BEHAVIOURAL ADVERTISING

As described above under paragraph 2.4., where you have provided your consent, we may use your Personal Information to provide you with targeted advertisements or marketing communications (by email, SMS or direct mail) we believe may be of interest to you.

6. TRANSFER OF PERSONAL DATA TO THIRD COUNTRIES

- the right to withdraw your consent at any time in case where the processing of your personal data is based exclusively on your consent;
- the right to ask the erasure of your personal data, under the condition that this particular data processing is based solely on your consent;
- \cdot the right to data portability;
- the right to contact the Hellenic Data Protection Authority (Tel.: +302106475600, Email: contact@dpa.gr) in case you are dissatisfied with how we process your personal data.

8. INFORMATION RETENTION

We retain your Personal Data for as long as it is necessary to fulfil any contractual obligations related to your purchase, such as refunds and guarantees, and to comply with any legal requirement.
